Review Report
To the shareholders of Alliance Insurance (PSC)**Introduction**

We have reviewed the accompanying interim condensed statement of financial position of Alliance Insurance (PSC) (the "Company") as at September 30, 2013 and the related interim condensed statement of comprehensive income, the interim condensed statement of changes in equity, and the interim condensed statement of cash flows for the nine months period then ended. Management is responsible for the preparation and fair presentation of these interim condensed financial statements in accordance with International Accounting Standard No. 34: Interim Financial Reporting ("IAS 34"). Our responsibility is to express a conclusion on these interim condensed financial statements based on our review.

Scope of Review

We conducted our review in accordance with the International Standards on Review Engagements 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity". A review of interim condensed financial statements consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with International Standards on Auditing and consequently does not enable us to obtain assurance as that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

Conclusion

Based on our review, nothing has come to our attention that causes us to believe that the accompanying interim condensed financial statements is not prepared, in all material respects, in accordance with IAS 34.

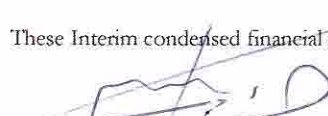

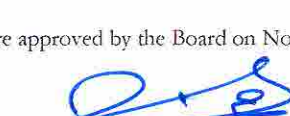

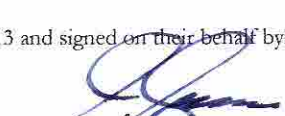

1. Legal status and activities

Alliance Insurance (PSC) ("the Company") is a Public Shareholding Company ("PSC") which was originally established in Dubai on July 1, 1975 as a limited liability company under the name of Credit and Commerce Insurance Company. The Company was subsequently incorporated in Dubai on January 6, 1982 as a limited liability company under an Emiri Decree. The Company became a PSC in January 1995, in accordance with the United Arab Emirates (UAE) Federal Commercial Companies Law No. (8) of 1984 (as amended).

The Company underwrites all classes of general, life and health insurance business in accordance with the provisions of the UAE Federal Law No. 6 of 2007 relating to insurance companies and insurance agents.

The registered address of the Company is Warba Centre, P.O. Box 5501, Dubai, UAE.

2. General information and basis of preparation

The interim condensed financial statements are for the nine months ended September 30, 2013 and are presented in Emirati Dirham (AED), which is the functional currency of the Company. They have been prepared in accordance with IAS 34 'Interim Financial Reporting' (IAS 34) and do not include all of the information required in annual financial statements in accordance with IFRSs.

3. Significant accounting policies

The interim condensed financial statements have been prepared in accordance with the accounting policies adopted in the Company's most recent annual financial statements for the year ended December 31, 2012, except for the application of the following standards as of January 1, 2013:

IFRS 13 Fair Value Measurement

IFRS 13 clarifies the definition of fair value and provides related guidance and enhanced disclosures about fair value measurements. It does not affect which items are required to be fair-valued. IFRS 13 applies prospectively for annual periods beginning on or after 1 January 2013.

Further, certain amendments to existing IFRS have been adopted by the Company:

- IAS 1 Presentation of Financial Statements- Amendment
- IAS 32 Financial Instruments: Presentation- Amendment
- IFRS 7 Financial Instruments: Disclosures – Amendment

Annual Improvements 2009-2011

The Annual Improvements made minor amendments to a number of IFRSs. The only amendment that affects these financial statements clarifies that the total assets and liabilities for a particular reportable segment are required to be disclosed in interim condensed financial statements if this information is regularly provided to the chief operating decision maker and there has been a material change since the most recent annual financial statements. As a result of this amendment the segment information in Note 7 now includes total liabilities as well as total assets.

3. Significant accounting policies (continued)

3.1. Significant management judgement in applying accounting policies

When preparing the interim condensed financial statements, management undertakes a number of judgements, estimates and assumptions about the recognition and measurement of assets, liabilities, income and expenses.

The following are significant management judgements in applying the accounting policies of the Company that have the most significant effect on the interim condensed financial statements. Critical estimation uncertainties are described in note 3.2.

Insurance liabilities

The estimation of the ultimate liability arising from claims made, claims incurred but not reported and unearned premium under insurance contracts are the Company's most critical accounting estimates. There are several sources of uncertainty that need to be considered in the estimate of the liability that the Company will ultimately pay for such estimates. The Company estimates for reported and unreported losses and establishing resulting provisions and related reinsurance recoverability is continually reviewed and updated, and adjustments resulting from this review are reflected in statement of comprehensive income. The process relies upon the basic assumption that past experience, adjusted for the effect of current developments and likely trends, is an appropriate basis for predicting future events.

Classification of investment property

The Company makes judgement to determine whether a property qualifies as investment property and follows the guidance of IAS 40 'Investment Property' to consider whether any owner occupied property is not significant and is classified accordingly as investment property at fair value.

3.2. Estimation uncertainty

Information about estimates and assumptions that have the most significant effect on recognition and measurement of assets, liabilities, income and expenses is provided below. Actual results may be substantially different.

Impairment

An impairment loss is recognised for the amount by which the asset's or cash-generating unit's carrying amount exceeds its recoverable amount. To determine the recoverable amount, management estimates expected future cash flows from each cash-generating unit and determines a suitable interest rate in order to calculate the present value of those cash flows. In the process of measuring expected future cash flows management makes assumptions about future operating results. These assumptions relate to future events and circumstances.

In most cases, determining the applicable discount rate involves estimating the appropriate adjustment to market risk and the appropriate adjustment to asset-specific risk factors.

3.2. Estimation uncertainty (continued)

Useful lives of depreciable assets

Management reviews the useful lives of depreciable assets at each reporting date, based on the expected utility of the assets.

Provisions

On a going basis, provisions are made for all known and reported claims, including handling costs, for all classes of business which have not been paid as at the reporting date and are stated gross with reinsurance portion being shown separately under current assets. An additional provision is made for the claims incurred but not reported (IBNR) at the reporting date on the basis of management estimates. The method used by the Company to calculate claims incurred but not reported takes into account historical data, past estimates and details of reinsurance programmes to access the expected size of reinsurance recoveries.

The Company is currently defending certain lawsuits where the actual outcome may vary from the amount recognised in the financial statements.

4. Investment property

All investment property of the Company is located within United Arab Emirates.

In the opinion of management, there has been no change in the fair value of investment property since December 31, 2012.

5. Financial assets (Continued)

Short term deposits comprise of fixed deposits with various banks bearing annual interest rates ranging from 1.6% to 4.5% p.a. (December 31, 2012: from 1.5% to 4.5% p.a.). The maturity of these deposits falls within one year.

Long term deposits comprise of fixed deposits with Emirates Investment bank bearing interest rate 5.25% p.a. (December 31, 2012: nil). The maturity of these deposits falls in 2018.

The net movement in fair value in the current period was an increase in value of AED 7,631,786 (December 31, 2012: increase of AED 7,501,894) which has been carried to the fair value reserve in equity.

6. Policyholders' funds

Policyholders' funds represent amounts set aside to meet the aggregate amount of the liabilities of the Company in relation to its long-term (life) business as at September 30, 2013.

The Company changed its consulting actuaries during the period from M/s Nauman Associates to M/s. Sidat Hyder Morshed Associates Limited. In their report dated October 23, 2013, M/s Sidat Hyder assessed a surplus of AED 8,044,341 in the Individual Life business as at September 30, 2013. The Company also assessed an additional surplus of AED 3,773,863 on account of Group and Medical division in Life Insurance Fund. Total surplus in Life Insurance Fund was AED 11,782,203 (December 31, 2012: AED 17,501,442).

7. Segment analysis

In identifying its operating segments, management generally follows the Company's lines of business. Each of these operating segments is managed separately as each of these business lines requires different resources as well as marketing approaches.

Under IFRS 8, reported segment profits are based on internal management reporting information that is regularly reviewed by the chief operating decision maker, and is reconciled to the Company profit or loss on the following page. The measurement policies used by the Company for segment reporting under IFRS 8 are the same as those used in its financial statements.

The Company operates two main business segments: General Insurance and Life Insurance. The main source of revenue for these operating segments is underwriting all classes of general insurance and life insurance policies.

8. Financial instruments measured at fair value

Financial assets and financial liabilities measured at fair value in the statement of financial position are grouped into three levels of fair value hierarchy. This grouping is determined based on the lowest level of significant inputs used in fair value measurement, as follows:

- level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities
- level 2: inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices)
- level 3: inputs for the asset or liability that are not based on observable market data (unobservable inputs).

9. Contingent liabilities and commitments

Legal cases

As at the period end, there were certain legal cases pending in different court of laws against the Company claiming AED 836,000 (December 31, 2012: AED 723,542) in total. The legal counsel is confident that these legal cases will be judged in favour of the Company.

Commitments

The Company's bankers have issued in the normal course of business Letters of Guarantee in favour of third parties amounting to AED 11,082,018 as of period end (December 31, 2012: AED 11,419,212).

10. Dividend

The Board proposed cash dividend of 15% of paid up capital, AED 15 million (AED 15 per share) for the year ended December 31, 2012 which was approved at the Annual General Meeting held on March 26, 2013 which was paid on April 07, 2013.
