Introduction

We have reviewed the accompanying interim condensed consolidated statement of financial position of Al Mazaya Holding Company K.S.C.P. (The Parent Company) and its subsidiaries (the Group) as of June 30, 2018 and the related interim condensed consolidated statements of profit or loss, profit or loss and other comprehensive income, changes in equity and cash flows for the six months period then ended. Management of the Parent Company is responsible for the preparation and presentation of this interim condensed consolidated financial information in accordance with International Accounting Standard 34, "Interim Financial Reporting". Our responsibility is to express a conclusion on this interim condensed consolidated financial information based on our review.

Scope of Review

We conducted our review in accordance with International Standard on Review Engagements 2410, "Review of Interim financial information performed by the Independent Auditor of the Entity." A review of interim condensed consolidated financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with International Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

Conclusion

Based on our review, nothing has come to our attention that causes us to believe that the accompanying interim condensed consolidated financial information is not prepared, in all material respects, in accordance with International Accounting Standard 34.

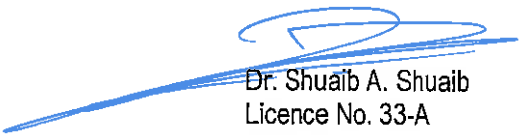
Other Matter

1. Incorporation and activities

Al Mazaya Holding Company "The Parent Company" is a Kuwaiti (Public) shareholding company listed on Kuwait Boursa and Dubai Financial Market and registered in the State of Kuwait, and was incorporated based on Memorandum of Incorporation under Ref. No. 3501 / Volume 1 dated November 7, 1998 and its subsequent amendments, the latest of which was notarized in the commercial registry pursuant to a memo issued from shareholding companies department under Ref. No. 213 dated April 1, 2014.

The Parent Company's main activities are Investing in local and foreign entities, real estate, and provide consulting services.

The Parent Company's registered address is P.O. Box 3546, Safat 13036, State of Kuwait.

The interim condensed consolidated financial information was authorized for issue by the Board of Directors on July 22, 2018.

2. Basis of presentation

The interim condensed consolidated financial information has been prepared in accordance with International Accounting Standard 34 "Interim Financial Reporting". The accounting policies used in the preparation of the interim condensed consolidated financial information for the period are consistent with those used in the preparation of the annual financial statements for the fiscal year ended December 31, 2017 except for the changes in accounting policies due to adoption of new standards as mentioned in the Note 3.

The interim condensed consolidated financial information does not include all the information and notes required for complete financial statements prepared in accordance with International Financial Reporting Standards. In the opinion of management, all adjustments consisting of normal recurring accruals considered necessary for a fair presentation have been included in the accompanying interim condensed consolidated financial information. Operating results for the period ended June 30, 2018 are not necessarily indicative of the results that may be expected for the year ending December 31, 2018. For further information, refer to the consolidated financial statements and notes thereto for the year ended December 31, 2017.

During the period ended June 30, 2017, the comparative information of of the Group's subsidiaries has been restated (in accordance with IAS 8 – Accounting Policies, Changes in Accounting Estimates and Errors). As a result, the subsidiary's net profit has been reduced by an amount of KD 673,087 as at December 31, 2016 and amount relates to the last quarter of 2016. Accordingly, the Group's retained earnings decreased by KD 673,087 and foreign currency translation reserve increased by KD 46,600 as at December 31, 2016.

3. Changes in accounting policies resulted from adoption of new standards of International Financial Reporting Standards

The key changes to the Group's accounting policies resulting from its adoption of IFRS 9, IFRS 15 and IFRS 16 are summarized below:

A) IFRS 9 - Financial Instruments

The Group has adopted IFRS 9 - Financial Instruments issued in July 2014 with a date of initial application of January 1, 2018. The requirements of IFRS 9 represent a significant change from IAS 39 Financial Instruments: Recognition and Measurement. The new standard brings fundamental changes to the accounting methods for the financial assets and to certain aspects of the accounting for financial liabilities.

1) Classification of financial assets and financial liabilities:

To determine their classification and measurement category, IFRS 9 requires all financial assets, except equity instruments and derivatives, to be assessed based on a combination of the entity's business model for managing the assets and the instruments' contractual cash flow characteristics.

Business model assessment

The Group determines its business model at the level that best reflects how it manages groups of financial assets to achieve its business objectives and in order to generate contractual cash flows. That is, whether the Group's only objective is to collect the contractual cash flows from the assets or is intending to collect both the contractual cash flows and cash flows arising from the sale of those assets. If neither of these is applicable (e.g. financial assets are held for trading purposes), then the financial assets are classified as part of 'Sell' business model and measured at FVPL. The Group's business model is not assessed on an instrument-by-instrument basis, but at a higher level of aggregated portfolios.

The IAS 39 measurement categories of financial assets (fair value through profit or loss (FVPL), available for sale (AFS), held-to-maturity, loans and receivables) have been replaced by:

- Debt instruments at amortised cost
- Debt instruments at fair value through other comprehensive income (FVOCI), with gains or losses recycled to the consolidated statement of profit or loss on derecognition
- Equity instruments at FVOCI, with no recycling of gains or losses to consolidated statement of profit or loss on derecognition
- Financial assets at FVPL

The accounting methods for financial liabilities remains largely the same under IAS 39, except for the treatment of gains or losses arising from an entity's own credit risk relating to liabilities designated at FVPL. Such movements are presented in OCI with no subsequent reclassification to the consolidated statement of profit or loss.

Debt instruments at amortized cost

A financial asset is measured at amortized cost if it meets both of the following conditions:

- The asset is held within a business model whose objective is to hold assets to collect contractual cash flows; and
- If the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest (SPPI) on the principal amount outstanding.

Debt instruments measured at amortized cost are subsequently measured at amortized cost using the effective yield method adjusted for impairment losses if any.

Debt instruments at FVOCI

The Group applies the new category under IFRS 9 of debt instruments measured at FVOCI when both of the following conditions are met:

- The instrument is held within a business model, the objective of which is achieved by both collecting contractual cash flows and selling financial instrument.
- If the contractual terms of the financial asset meet the SPPI analysis.

FVOCI debt instruments are subsequently measured at fair value with gains and losses arising due to changes in fair value recognized in OCI. Interest income and foreign exchange gains and losses are recognized in consolidated statement of profit or loss. On derecognition, cumulative gains or losses previously recognized in OCI are reclassified from OCI to consolidated statement of profit or loss.

Equity instruments at FVOCI

Upon initial recognition, the Group may elect to classify irrevocably some or all of its equity instruments at FVOCI when they meet the definition of Equity under IAS 32 Financial Instruments: Presentation and not being held for trading. Such classification is determined on an instrument-by-instrument basis.

Gains and losses on these equity instruments are never recycled to consolidated statement of profit or loss. Dividends are recognized in profit or loss when the right of the payment has been established. Equity instruments at FVOCI are not subject to an impairment assessment. Upon disposal, cumulative gains or losses are reclassified from cumulative changes in fair value to retained earnings in the consolidated statement of changes in equity.

Financial assets at FVPL

All other financial assets which are not classified at amortized cost or FVOCI as mentioned above are measured at fair value through profit or loss which includes all financial derivative assets. After initial recognition, the Group can irrevocably designate the financial asset within the financial assets at fair value through profit or loss if that classification significantly eliminates or reduces the inconsistency of its accounting method which might arise when other than that classification is used.

Financial assets at fair value through profit or loss includes financial instruments held for trading which were acquired or purchased principally for the purpose of profit making in the short term through trading activities or if it is a part from an identified portfolio of financial instruments that are managed and has a recent actual pattern of short-term profit making.

Financial assets at fair value through profit or loss are measured and recorded at fair value in the consolidated statement of financial position. Change in fair value, interest revenue, and dividend income from financial assets at fair value through profit or loss are recorded in the consolidated statement of profit or loss in accordance to the contractual terms or when the Group's right to receive the payment has been established.

2) Impairment of financial assets:

The adoption of IFRS 9 has fundamentally changed the Group's accounting for impairment losses for financial assets by replacing IAS 39's incurred loss approach with expected future credit loss (ECL) approach.

IFRS 9 requires the Group to record an allowance for ECLs for all debt instruments not held at FVPL.

ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive. The shortfall resulted from that difference is then discounted at an approximation to the asset's original effective interest rate.

For trade and other debit balances, the Group has applied the standard's simplified approach and has calculated ECLs based on expected credit losses during its entire lifetime. The Group has established a provision matrix that is based on the Group's historical credit loss experience, taking into consideration the expected factors for the debtors and the economic environment.

3) Transition:

The following changes in accounting policies are based on the requirements of the initial adoption of IFRS 9:

- Comparative periods have not been restated. Differences in the carrying amounts of financial assets and financial liabilities resulting from the adoption of IFRS 9 are recognized in retained earnings and fair value reserve as at January 1, 2018. Accordingly, the information presented for the financial year ended December 31, 2017 and the period ended June 30, 2017 in the accompanying interim consolidated financial information does not reflect in general the requirements of IFRS 9 but reflect the requirements of IAS 39 and therefore the interim consolidated financial information for the period ended June 30, 2018 is not comparable to the information included in the financial year ended December 31, 2017 and the period ended June 30, 2017 in term of the requirements of these standards.

B) IFRS 15 Revenue from Contracts with Customers

This Standard is effective for annual periods beginning on or after 1 January 2018, which establishes a single and comprehensive framework for determining whether, how much and when revenue is recognized. The standard replaces IAS 18 "Revenues", IAS 11 "Construction Contract" and several revenue – related Interpretations and provides a new control-based revenue recognition model using five-step approach to all contracts with customers

The five steps applied in this model are as follows:

- Identify the contract with the customer;
- Identify the contractual obligations;
- Determine the transaction price from contract;
- Allocate the transaction price to the contractual obligations;
- Revenue recognized when (or as) the Group satisfies its contractual obligation performance.

The Group is mainly operating in renting, developing, selling, and managing properties, accordingly; it acquires fees in return of renting and managing these properties. Residential units and sold properties are not relating to goods and services, accordingly; the related transactions are not including variable returns, the Group do not have contractual guarantees with its customers.

The Group's management has determined that there is no significant impact on the interim consolidated financial information of the Group as at the date of initial application of this Standard. In addition, no changes are required to the opening balance of retained earnings as at January 1, 2018 based on the requirements of IFRS 15.

C) IFRS 16 - Leases

The Group has early adopted IFRS 16 - Leases using a modified retrospective approach as this standard will be effective for annual periods beginning on or after January 1, 2019. This standard replaced IAS 17 "Leases". The new standard does not significantly change the accounting for leases for lessors and requires lessees to account for all leases under a single on-balance sheet model in a similar way to finance leases under IAS 17 with limited exceptions for low-value assets and short term leases. At the commencement date of a lease, a lessee will recognize a liability against an asset representing the right to use the underlying asset during the lease term. The early implementation of this standard has no significant effects on the accompanying comparative financial statements and opening balances.
