

Invitation to attend the General Assembly Meeting of Alliance Insurance PSC

The Board of Directors of Alliance Insurance PSC has the honor to invite the shareholders to attend the General Assembly Meeting to be convened at 11:00 am on Thursday 05/09/2024 at Company's Head Office and remotely via video technology through TEAMS Application to consider the following agenda:

- Special resolution: to consider and approve the amendment of the Company's Articles of Association to align with article 10.2 from Commercial companies Law concerning Rate of National Contribution and Article 4 of the Cabinet Resolution No. 42 of 2009 Concerning Insurance Company Minimum Capital Regulations amended by form 15/5/2017 and article 5.9 from Corporate Governance Regulation for Insurance Companies 24/2022, after obtaining Authorities approval. Articles to be amended will be available on the company's & DFM websites prior to the General Assembly Meeting.

Notes:

1. Any shareholder who has the right to attend the General Assembly may delegate any person other than a member of the Board of Directors under a special written proxy. In such capacity, no proxy may represent more than 5% of the shares in the capital of the Company. Shareholders who lack capacity of competency shall be represented by their legal representatives. Subject to point 1&2 of article (40) of the Authority Chairman's Decision No. (3/R.M) 2020 concerning Corporate Governance guide.
2. A corporate person may delegate one of its representatives of those in charge of its management under a decision of its Board of Directors or its authorized deputy to represent such corporate person in the General Assembly of the Company. The delegated person shall have the powers as determined under the delegation decision.
3. Shareholders may appoint any of company's legal representatives, which their details' are available on Company's website.
4. Shareholder registered in the Shareholders' Register on Wednesday 04/09/2024 has the right to vote in the General Assembly Meeting.
5. SMS containing link of the Registration, Attendance, eVoting and access code will be sent to shareholders one day prior to the General Meeting on Wednesday 04/09/2024.
6. Shareholder is able to register (registration for attendance) and vote upon receiving the link and until the commencement of the General Assembly at 11:00 am on Thursday 05/09/2024 and the vote will continue until end of the General Assembly.
7. eVoting will only be extended for shareholders registered before the AGM commencement until the end of the AGM.
8. Special resolution: is a resolution passed by majority vote of the shareholders who hold at least $\frac{3}{4}$ of the shares represented in the General Assembly meeting.
9. Shareholders can view the amendments of the Articles of Association on Company's website <http://www.alliance-uae.com> and Dubai Financial Market website.
10. Shareholders can attend online live streaming of the General Assembly through the link which will be sent one day before the General Assembly date.
11. The meeting of the General Assembly shall not be valid unless attended by shareholders who hold or represent by proxy at least (50%) of the Company's share capital. If this quorum for the meeting is not available in the first meeting, the second meeting shall be convened on 12/09/2024 in the same place and time. The postponed meeting shall be deemed valid irrespective of the number of the shareholders present.
