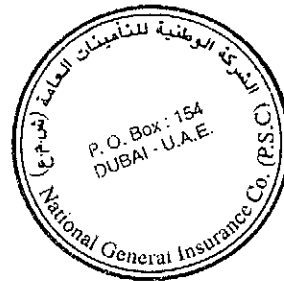
FINANCIAL HIGHLIGHTS THE SIX MONTHS ENDED 30 JUNE 2012

The Company has achieved Gross Written Premium of AED 252.68 Million for the period ended 30 June 2012 as compared to AED 252.48 Million in the previous year.

The Underwriting profit for the period ended June 2012 is of AED 21.56 Million as compared to AED 22.98 Million for the same period of 2011. Net profit for the period ended 30 June 2012 amounted to AED 26.3 Million compared to AED 33.17 Million in 2011 due to drop in investment income.

The total equity is AED 324 Million as at 30 June 2012 as compared to AED 319 Million as at 31 December 2011.

The total asset as on 30 June 2012 was 886 Million as compared to AED 861 Million as at 31 December 2011.
